## INFORMATION REQUIREMENT CLAUSE

Pursuant to provisions of the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC ("GDPR"), the University of Humanities and Economics in Lodz, 90-212 Łódź ul. Sterlinga 26, hereby provides the required information on personal data processing.

1. The Data Controller with respect to your personal data is **the University of Humanities and Economics in Lodz**, ul. Sterlinga 26, 90-212 Łódź. The Data Controller can be contacted via e-mail: [uczelnia@ahelodz.pl](mailto:uczelnia@ahelodz.pl), or in writing, by sending a letter to the Data Controller's registered office, with a note "Personal data protection".
2. The Data Controller hereby informs that, in order to guarantee appropriate protection of personal data, it has appointed a Data Protection Officer who can be contacted via e-mail: [iod@ahelodz.pl](mailto:iod@ahelodz.pl). In all matters concerning personal data processing and execution of your rights arising from such processing, you can contact the Data Protection Officer.
3. The legal basis for processing of your personal data is Art. 6, section 1, letter f) of GDPR. Legally justified interest of the Data Controller is contact with the Author in matters concerning preparation of the article (work) and possible pursuing or defence of claims. Your personal data can be also processed under Art. 6, section 1, letter a) of GDPR within the scope and for the purposes specified in a voluntary consent for personal data processing, which can be withdrawn any time. Providing personal data is voluntary, however necessary for the above-mentioned purposes specified by the Data Controller. Personal data is not subject to automated processing, including profiling.
4. Personal data shall be processed only as long as it is necessary to secure possible claims until their limitation period expires as per the applicable provisions of law. In case the legal basis for data processing is a consent, personal data shall be processed until such consent is withdrawn.
5. The recipients of personal data can be third-party entities providing and supporting the Data Controller's IT systems, as well as other entities cooperating with the Data Controller within the scope of its current activity — pursuant to appropriate personal data processing agreements and subject to a guarantee that the above-mentioned entities employ adequate technical and organizational measures with respect to data protection. Personal data can be also made available to entities authorized to such access under applicable provisions of law. In principle, personal data shall not be transferred to any third countries or international organizations. However, in certain situations personal data can be transferred to countries outside the European Economic Area. In such cases, the Data Controller shall take care of any formalities regarding the correct protection of personal data, including conclusion of standard contractual clauses adopted by the Commission (EU).
6. Any person whose data is processed under the applicable provisions of law shall be entitled to have access to their data, correct it, remove it and limit its processing, as well as to transfer their data and object to its processing.
7. You have a right to withdraw the consent for your personal data to be processed any time — provided that the legal basis for such processing is your consent, however such withdrawal of consent shall not affect the legality of processing that has already taken place prior to the withdrawal.
